RATES AND CHARGES

§ 52.15 GENERAL PROVISIONS.

The town has previously established rates and charges and fees for the provision of gas to its customers by previously adopted Ords. 2000-1, 2006-2, 2006-9, 2007-2, and 2007-5, which rates and charges and fees are restated herein.

- (A) In the case of rental property or property purchased on installment land sale contract, both the renter/purchaser and the property owner shall be responsible for any unpaid gas utility bills.
- (B) Each customer shall pay a minimum monthly rate in accordance with the type of the meter installed and the amount of gas usage. The rates and charges of the town municipal gas utility are established by ordinance duly adopted by Town Council for the town and are as follows. (Ord. 2008-1, passed 1-8-2008; Ord. 2015-2, passed 10-20-2015)

§ 52.16 MINIMUM CHARGES.

- (A) Each customer shall pay a minimum monthly gas meter charge per meter in accordance with the type of meter installed, to-wit:
 - (1) Residential(R-275 meters): \$5 per month;
 - (2) Small commercial (415 to 900 series meters): \$12 per month; and
 - (3) Medium and large commercial and industrial (rotary meters): \$25 per month.

(B) In addition, there will be a \$300 service reconnection charge for reconnection of service meters, which shall be paid prior to meter reconnection. (Ord. 2008-1, passed 1-8-2008; Ord. 2015-2, passed 10-20-2015)

§ 52.17 METERED CONSUMPTION.

Usage of gas will result in the following rates and charges for the quantity of gas supplied during each monthly billing period:

- (A) First 800 cubic feet: \$7.43 per 1,000 cubic feet;
- (B) Next 1,200 cubic feet: \$5.98 per 1,000 cubic feet;
- (C) Next 98,000 cubic feet: \$5.58 per 1,000 cubic feet; and
- (D) Over 100,000 cubic feet: \$5.32 per 1,000 cubic feet. (Ord. 2008-1, passed 1-8-2008; Ord. 2015-2, passed 10-20-2015)

§ 52.18 SURCHARGE FOR OUT OF TOWN CUSTOMERS.

A gas surcharge of \$0.50 per each 1,000 cubic feet of gas shall be added to the usual rates and charges for gas service to those customers of said gas utility that are located outside the corporate boundaries of the town, and shall be included in the monthly billings therefor. (Ord. 2008-1, passed 1-8-2008; Ord. 2015-2, passed 10-20-2015)

§ 52.19 COST ADJUSTMENT.

There will be a gas cost adjustment increment included in each monthly bill that shall be computed on a monthly basis in accordance with the gas cost adjustment procedures of the state's Utility Regulatory Commission.
