Water Department – Tony Wood stated that meters are ordered to update Napoleon Water and the trailer park. They installed an actuator valve today and have a backup if needed. Paul will be taking his DSM License test and Alex is studying for her Class 1 Wastewater License.

Sewer Department – Tony Wood stated that he has a draft NPDES Permit for the next 5 years. There will be less frequent testing to save money. There will be copper and cyanide limits given. They installed a gear box in the bar screen.

Police Department – Daniel Craig stated that he had given a written violation to the residence on Morris Street from all the complaints and they have complied. They addressed the speeding on S. Buckeye and

had 30 traffic stops. Chris Kuhn asked if we had signage for the jake break ordinance, this will be looked in to. Daniel also stated that the Morris Street sign was much appreciated.

Fire Department – Riley Thomas stated they had 26 runs with 1 EMS run that they did not make. They now have 23 out of the 26 slot roster filled and they gained 4 cadets. They have an in house class planned where 9 or 10 will go through. David Fox, Riley Thomas, and one other will take the National Fire Training class.

Brandon and Ashley Love were present to get the update on their concerns from last month's meeting. They were very happy to hear the numbers and improvements. They have not seen any more cars passing school buses.

The Police Department grant has been written and will be ready to submit.
