Introducing for the first reading Ordinance 2023-1: An Ordinance Amending Rates and Charges for Potable Water Service to Customers of the Town of Osgood Water Utility. The Town of Osgood employed Baker Tilly Municipal Advisors to undertake a study of cost of providing potable water to the customers of the Town's Water Utility. Baker Tilly rendered an opinion to the Town Council that the Town's current rates and charges are not adequate to pay for the cost of providing potable water to the customers of the Town's Water Utility. It is unlawful for the Town to charge less than the Town's cost of providing potable water to the customers. Baker Tilly has recommended a utility rate increase to be phased in over a five year period. A public hearing will be held on Tuesday, April 18th at 7:00 p.m. for the proposed rates and charges.

Police Department - Daniel Craig reported everything was good.

Reyna Jackson was present and stated the problem at Hometown Auto is worse. Lynn Fledderman advised that it is still in litigation.

John Bunselmeier was in attendance and approached the Council with an issue, concerning storm water drainage at his property on State Road 350. He asked when the Town would be maintaining the storm water release and repair the damage to his property. He spoke to someone at the county level concerning his storm drainage issue and they are saying it's not their problem. He stated that storm water is being released into the unnamed tributary that runs on his property. He is requesting information on the 2019 Culvert Project the Town did per the Freedom of Information Act. Lynn Fledderman asked him to submit his inquiries in writing so there is no confusion. Mr. Bunselmeier asked if an email from the Ripley County Surveyor, Jeff French, concerning the drainage issues had been read by council. Lynn stated that the email was read and that it did not state the Town is liable for any drainage issue on his property. She stated that we've already concluded that it's not damage that the Town had created and in response to his concerns a written response was sent to his attorney. Mr. Bunselmeier stated he did not receive it. Lynn advised him to seek that information from his legal counsel. He stated he did not have legal counsel. Mr. Bunselmeier submitted a letter to Council requesting the documents from the 2019 Culvert Project. Lynn stated that the Town will respond to the public record request.
